### **Convention 2020 - Tammy James and Sue Foy**

Sue, Chair and Tammy, Co-Chair and Lou Ann, Back-up, reported the 2020 VSC State Convention is a work in progress. They have met regularly with the hotel, inspected the meeting sites and discussed ways to set-up the rooms. They encourage members and their families to come to Virginia Beach May 15 - 17, 2020 at the Holiday Inn, Virginia Beach/Norfolk Hotel and Conference Center, 5655 Greenwich Road, Virginia Beach, VA. Room rates are \$119 per night. The theme is "Party At The Beach".

Top Golf, which is an indoor golf facility, is located two blocks from the hotel. It has a restaurant, bar and children's play area.

### Disaster Fund - Debbie Langfitt - Report under Jr. Past President

Jenny passed the donation basket for the Disaster Fund.

### **Easter Seals - Bev Scott**

Bev stated that our new Easter Seals Project for this fall is "Count your Blessings for Easter Seals". She asks that each chapter ask each member to donate just \$1.00 each for your children and grandchildren (and fur babies too). This is in recognition of Easter Seals 100<sup>th</sup> Anniversary Celebration. If you prefer to make a personal donation with a check make it payable to Easter Seals and she will forward it to the Salem office. All donations to Easter Seals are tax deductible. All donations will be used for infant and children's programs as well as families needing Easter Seals support.

A basket was passed for donations.

### **Education Chairman - Susan Caldwell\***

Susan felt the Leadership was an Educational in itself. She provided a copy of 50 Ways to Take a Break. (Copy attached).

### **ESA Foundation Coordinator** - Sue Foy

Sue announced that at IC Virginia was recognized by the IC Foundation as a First Place winner in funds donated to the Foundation in 2019. The VSC was credited with over \$30,000 this year (thanks to the generous giving though the Foundation Planned Giving Program in Flora's estate planning). Fifty-three members were certified to vote at IC.

She thanked members and chapters for paying their dues and reminded them the deadline is March 1.

She announced that P-Nut Schools is a new Lifetime Giver. She encourages members to become a Lifetime member. The Foundation is offering a special that if two members become Lifetime members the Foundation will give away \$100 which can be used for another Lifetime membership or other projects such as paying chapter Foundation dues.

Sue said there are more chapters using the Turn-Around Funds. This helps the Foundation maintain their 501(3)c IRS charity designation.

Virginia member sponsored scholarship money awarded was \$33,800. A General Honorarium was given in Sue's name for \$1,000.

There were 168 scholarships given by the Foundation in the amount of \$270,100 this year. Since 1974, 3,661 Scholarships have been provided with a total amount of \$3,444,603.

Grants for continuing education were given this year along with the B J Clark ART Grant. This is a program where a charity partners with the Foundation to fund a charity project. The Foundation does the clerical work and the chapter does the physical running of the program.

The Foundation was able to give St. Jude Children's Hospital a grant of \$50,000 to fund a student in the St. Jude Graduate School of Biomedical Sciences. Each year the school will receive \$10,000 to help students in this field.

Members receiving the Plateau of Achievement Awards were: Brenda Bowersox, Debbie Langfitt, Mindy Boyd, Theresa Morris, Trisha LaBlanc, Beverly Scott, Flora Burns Estate and the VSC.

The Foundation needs Ann Taylor's mailing address. Ann was at the meeting and will get that info to the Foundation.

### **ESA for St. Jude Coordinator - Carol Campbell**

Carol was excited to share with the VSC that Virginia made it in the top ten at IC. Virginia's total is \$974,647. Virginia's reached a milestone of \$12 million accumulated total to date.

Carol said there were three dream houses built this year. Hampton Roads, Richmond and SW/Central VA (Roanoke Area). She spoke about the Roanoke area chapters and the help received to make the project happen. She thanked Beverley Wright from Gamma Pi for her help and presented her a monogrammed St. Jude bag. Carol also thanked the Richmond members for their help.

The next Dream House is slated for the Lynchburg area and she said there will be opportunities for other area chapters to assist in this new location. WSET-TV volunteered to promote the Dream House and said it would have to be closer to their facility for them to do it.

She reminded everyone to use the Booked and Completed forms for all St. Jude events. She asks that you share your ideas with her. If you have questions please contact Carol.

Carol reminded members that if you want to serve as the St. Jude Coordinator to let the incoming President know and fill out a Willing to Serve form. Carol said she has enjoyed serving in this capacity for the 2<sup>nd</sup> time.

### Finance Director - Barb Smith - Absent

Barb was not able to be at the meeting. Jessica Udan and Jenny Brunnell sold the tickets for the Lucky Numbers.

### Historian - Jane Parrish

Jane emphasized how important it is to record your chapter history. She is requesting that chapters submit a monthly record including their socials, educational programs, fundraising projects, and volunteer hours. The deadline for the histories is April 15<sup>th</sup>. Her address is: 308 Ridge Avenue, Winchester, VA 22601.

### 2018-2019 Historian - Elaine Prillaman

Elaine said she enjoyed doing the History for Debbie's year as VSC President. Nine chapters submitted a history. Due to Debbie being absent the History was given to Jenny to take to Debbie.

### **Hope for Heroes - Ginny Hatchell - Absent**

In Jenny's absence Beth Sherron set-up a "Missing Man" place setting in honor of our fallen heroes. A basket with flag pins was on the table if anyone wanted to make a donation. This will be continued at SERC.

She has received 10 summer reports thus far. She reminded everyone that due to the recent change in awards this report can be sent at any time until April 15. Lynne encourages chapters to send their reports in as they do them.

### **Leadership Conference 2019 - Susan Caldwell**

Susan reported 39 had registered for Leadership. Thirty-eight attended. Susan thanked Mike and Suzanne for setting up the AV and she thanked her chapter members for bringing in the food and drink. To assist in raising the totals this year, she and Judy, along with the support of Beth Sherron, will be holding another Quilt Raffle. There are three quilts. Beth made two quilts, one with fall colors and one with breast awareness colors. Theresa made the third quilt with bright blue and yellow fabric. Chances are \$5 each or 3 for \$10. The drawing will be held at State Convention.

### Feedback from Chapter Surveys - Diane McLane\*

Diane received seven chapter surveys and presented the results in a Powerpoint presentation. (Copy attached). Overall the membership is satisfied with the way things are being done. Discussion was heard on increasing membership. Total membership is approximately 117 members. Lou Ann learned at IC a Cheerleader has been assigned to Virginia to help with anything we need to recruit new members. Her name is Amanda Rowland from Ohio. She was selected because she has been successful in getting new members.

### **Unfinished Business:**

### 1. Flora's Brick

Lou Ann reported money for Flora's brick was passed off to Rich Peterson at IC. We are now waiting to hear when it will be ready to be placed at St. Jude.

### 2. Outstanding Chapter Award

Beverley Wright reported that the PPA's will continue the Outstanding Chapter Award with changes. She will draft changes and send to the PPA's for review and input. A new form will be available at the March meeting.

### 3. Discussion of the June Meetings

Lou Ann reported the Executive Board had discussed doing away with the June meetings due to expenses for the President and her chapter and the low attendance at the June meetings over the past years. Discussion followed:

- Sandy Reed asked how and when the budget would be adopted; another concern she has is the reimbursement for the incoming President's expenses to attend IC.
- Bev Scott agrees to do away with June meeting. She said the cost of travel, hotel and other items is expensive and very few members attend. She suggested the budget could done electronically. She said the Executive Board could meet prior to the fall meeting. She suggested that the fall meeting be held in September.

- Sue Danielson's concern is the lost income from the June lucky numbers. She also mentioned that new members taking a place on the board won't get as comfortable in front of the membership when they give their reports.
- Bev Scott asked how many new members were at the June meeting and at the October meeting.
- Carol Campbell asked if the June meeting could be in a central location such as Staunton or Waynesboro.
- Brenda Bowersox said she had been a member in another State and the President's expenses for IC had been budgeted in the prior year. The first year, if this is done, the President's expenses for two members would be in the budget, but after the first year it would only be one expense.
- Sandy asked why the budget couldn't be adopted at the Convention.

Lou Ann said we are looking at alternatives for the June meeting. This will be added for the March meeting By-law change to discuss.

### **New Business:**

### 1. SERC Attendance

Lou Ann asked how many members would be attending the SERC Conference in Raleigh. Approximately 15 members raised their hand. Virginia is to help with seating for the banquet at the SERC Conference on Saturday night. Registration has been extended to October  $10^{\rm th}$ .

### 2. SERC Candidates

If there are no objections from the membership, the Executive Board has approved we dispense with the reading of the candidates for SERC Offices because the slate of officers are available as published on the SERC Website.

Sue Foy, Beta Kappa moved that the voting for the SERC candidates be left to the discretion of the members attending SERC. Coming from the Executive Board no second is needed. Motion carried.

### 3. **SERC By-Laws**

If there are no objections from the membership, the Executive Board has approved we dispense with the reading of the By-law changes for SERC because the By-laws are available on the SERC Website.

Sue Foy, Beta Kappa moved that the voting for the SERC By-law changes be left to the discretion of the members attending SERC. Coming from the Executive Board no second is needed. Motion carried.

### 4. SERC Convention Ad Booklet

Jenny Brunnell, Delta Rho moved the VSC submit an a quarter page ad for the SERC Booklet at a cost of \$25. Coming from the Executive Board no second is needed. Motion carried.

### 5. SERC Courtesy Bid

Virginia received a request to submit a courtesy bid for the 2022 SERC Convention. The Executive Board discussed this at their meeting and at this time Virginia will not submit a bid.

### 6. Paypal Account

Lou Ann announced Beta Kappa is considering setting up a Paypal account for the Convention in Virginia Beach this year. If members would like to pay their convention registration this way it will be available. Checks will also be accepted. Lou Ann said there needs to be a way to pay registration if you do not use a checkbook.

Beth Sherron reminded everyone to be aware of any additional charges and fees.

A program called VENMO was suggested. This is also an electronic means for payment. More information on this will be forthcoming from Beta Kappa.

### 7. Webpage OverhauL

After discussion and approval from the Executive Board, Lou Ann spoke with Mike Smith about getting a new website for the VSC. Mike is in agreement. The site we have now is very complex. A new site would be clean, easy to use and we would be able to share the duties with more than one person. More information will be forthcoming on this.

### 8. Fundraising

Lou Ann reminded members that per the Standing Rules anyone conducting a fundraiser at a VSC meeting should get prior permission from the Executive Board.

### 9. Fundraising Ideas to Bring Money Into the Treasury

The Executive Board discussed ways to increase the treasury. It was decided with a By-law change the VSC dispense paying one-half of the registration for the Officers attending convention. The President's registration would still be paid in

full. Marie LaDuke, Parliamentarian, will add this to the By-law changes for the March meeting.

### **Book Challenge:**

Lou Ann has challenged everyone to read *Still Life* by Louise Penny. I struggled as to what to say today but felt we should take a few moments to remember these ladies now rather than wait until next May.

It is said, "When someone you love becomes a memory, that memory becomes a treasure." My memories of these 4 ladies are very diverse. June was the quintessential ESA lady - always dressed stylishly with a deep respect for the rules and order of our sorority. I knew Lisa probably the longest as she was a part of two chapters in Waynesboro and the Blue Ridge District Council when it existed. Lisa was very focused, knowing that she wanted to be VSC State President and SERC President and had the tenacity and determination to put herself out there time and again until both of these became a reality. Lisa always wore a brownish/pink nail polish, which I thought was so unusual (at the time) and gave generously of herself and her resources to support ESA. Now Barbara was one of those people who made an impression before you even formally met her. Her distinctive voice, raucous laughter and love of dancing were integral parts of her persona. She was a self-made woman in many ways, and her honesty and forthrightness endeared her to many but not to all. Finally, Kathy was a sister whom I did not know very well, even though I was impressed by her involvement in ESA. She inspired friendship with many outside of her chapter and her willingness to do any job made her such an asset to this council.

All of these ladies will be missed in different ways by so many of us. We will pay homage to them at the Celebration of Life Service in May, but the wound of loss is fresh now.




