Zeta Nu). The convention will be held at the Hilton Garden Inn in Roanoke on May 20 – 22, 2022 and the theme selected is, “Southern Starts Here”. Ginger Hodges, Beta Delta, will serve as Chairman with Elaine Prillaman, Delta Kappa, as Co-Chairman.

In accordance with Article 8, Section 2 of the VSC Bylaws, if only one bid is submitted, voting may be by general consent. The bid was accepted by general consent of the voting members in attendance.
